

Track record over the last 26 years

Our initiatives have saved taxpayers \$60.1 billion so far (2000-2024)

My friends, I have been fighting for taxpayers for 26 years.

- 1997 – Initiative 200 – banned race & gender preferences (govt affirmative action).
- 1998 – Initiative 691 – lowered car tab taxes.
- 1999 – Initiative 695 – \$30 car tabs and voter approval for tax increases.
- 2000 – Initiative 722 – 2% cap on property tax increases.
- 2001 – Initiative 747 – 1% cap on property tax increases.
- 2002 – Initiative 776 – \$30 car tabs.
- 2003 – Initiative 18 – reduced King County Council from 13 politicians to 9.
- 2004 – Initiative 864 – 25% reduction in property taxes.
- 2005 – Initiative 900 – state auditor empowered to do performance audits of gov'ts.
- 2006 – Initiative 917 – \$30 car tabs.
- 2007 – I-960 reestablished the 2/3 legislative vote requirement to raise taxes.
- 2008 – I-985 improved transportation using existing taxes instead of raising taxes.
- 2009 – I-1033 lowered property taxes by capping the growth of government.
- 2010 – I-1053 reestablished 2/3 vote to raise taxes after Legislature repealed it.
- 2011 – I-1125 limited vehicle taxes & I co-sponsored numerous local city initiatives that succeeded in banning red-light ticketing cameras in those cities.
- 2012 – I-1185 renewed the 2/3 legislative vote to raise taxes (overwhelmingly passed)
- 2013 – I-517 protected the initiative process
- 2014 – I-1325 pushed for 2/3-for-taxes constitutional amendment
- 2015 – I-1366 pushed for a 2/3-for-taxes const. amendment (overwhelmingly passed)
- 2016 – Pushed for 2/3-for-taxes constitutional amendment (got senate to pass 2/3 rule)
- 2017 – I-947 “Bring Back Our \$30 Car Tabs”
- 2018 – I-976 \$30 Tabs (sold off family’s retirement fund & loaned \$500K to kickstart it).
- 2019 – I-976 \$30 Tabs, Give Them Nothing (stop pay raises for politicians), & Term Limits on Taxes (block 11 tax increases). I-976 overwhelmingly approved.
- 2020 – While running for Governor, I pushed numerous projects including legal defense of I-976 \$30 Tabs and multiple lawsuits challenging Inslee’s lockdown (OPEN SCHOOLS NOW, ALL BUSINESSES ARE ESSENTIAL, MASK MANDATE).
- 2021 – WA STATE: defending the initiative process and tax advisory votes, stopping Pay-Per-Mile Taxes, Higher Car Tab Taxes, and capital gains income tax.
- 2022 – WA STATE: Stop All Income Taxes Initiative. NATIONWIDE: In 7 key swing states: 7 Election Integrity Initiatives (photo ID to vote, etc).
- 2023 – WA STATE: beat back all tax increases, pushing to bring back our \$30 tabs and stopping all income taxes. NATIONWIDE: In next cycle, we are targeting 10 key swing states w/ Election Integrity Initiatives (photo ID to vote, etc).
